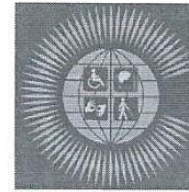

3. Has your country ratified the UNCRPD and when?

Malaysia ratified the UNCRPD on 19 July 2010, with reservations to Articles 15 and 18. Malaysia has not signed the Optional Protocols for this Convention.

4. What has your country done to Implement the UNCRPD?

- **Enacted Person with Disabilities Act 2008**
- **Formulated plan of Action for PWD's 2016-2022**

5. How much is your DP0 involved in implementation with the Government of your country?

Working together with the Government in the implementation of programmes in accordance with CRPD.

6. Has your DPO been involved in producing a shadow report to go to UNCRPD Committee and how?

Malaysia has not tabled its country report, therefore DPO's have not produced the shadow report.

7. What progress has been made on implementing Inclusive Education?

45% enrollment in 2020.

8. What progress has been made on social protection for PWD?

- **PWD's earning less than USD 300, provided a USD 100 Disability allowance a month.**
- **Those severely disabled and unable to work provided USD 60 assistance per month.**
- **Caregivers of those severely disabled provided USD 100 per month.**

9. What progress has been made in implementing employment opportunities for PWD?

1% quota in the public service allocated for PWD's but by 2020. Only 0.33% has been filled.

10. What progress has been made on challenging negative attitudes and stigma to PWD?

Public Awareness programmes through electronic and print media and social activities are constantly organised by the Government, private sector and NGO's.

11. What progress has been made in achieving gender equality for PWD?

It is still in progress.

12. What capacity building does your DPO need? Identify areas.

- **Understanding CRPD**
- **Shadow report writing**
- **Advocacy and lobbying**

13. If you are the National Umbrella DPO, how do you operate democratically with other DPOs?

National DPO's are invited to become members while state DPO's becomes affiliate members.
