Mozambique

3. Has your country ratified the UNCRPD and when?

Yes, Mozambique ratified the convention in 2012

4. What has your country done to Implement the UNCRPD?

Mozambique has not designed a specific plan to implement the CRPD since the ratification in 2012. We still have policies and laws that violate rights of persons with disabilities, including the right to legal capacity. In January this year the Government submitted the initial report to the Committee on the Rights Persons with Disabilities.

5. How much is your DP0 involved in implementation with the Government of your country?

AMUSAM has been collaborating with the Government, particularly with the Ministry of Health and the Ministry of Gender, Child and Social Protection. Last year we organized the first National Conference on Human

6. Has your DPO been involved in producing a shadow report to go to UNCRPD Committee and how?

Not yet.

7. What progress has been made on implementing Inclusive Education?

In Mozambique, the Government has just approved the National Strategy on Inclusive Education (2020 - 2029). The document presents a very progressive in some aspects such the early childhood development. However, it also presents some incompliances with the UNCRDP.

8. What progress has been made on social protection for PWD?

The Government has social protection schemes for vulnerable people and persons with disabilities benefit from those schemes. However, the number of people accessing social protection is too small. Most people with disability live in poverty barely accessing basic services.

9. What progress has been made in implementing employment opportunities for PWD?

Mozambique does not have any specific policy to improve the employment rates amongst persons with disabilities, which are disproportionately low comparing to other people without disabilities. Some private companies have volunteered to employ persons with disabilities in the recent times.

10. What progress has been made on challenging negative attitudes and stigma to PWD?

DPOs, including AMUSAM, have been conducting awareness raising campaigns all over the country and somehow it has been impacting attitudes.

11. What progress has been made in achieving gender equality for PWD?

No progress has been made in that regard.

-Human rights and advocacy;
